Sub:- Issuing of Building Safety Certificate in favour of Bhavan's B.P.Vidya Mandir, Koradi towards compliance of Central Board of Secondary Education.

With reference to the above letter, the following buildings were inspected by Shri.S.G.Allewar, Sub Divisional Engineer, P.W.Sub Division, Kamptee on Dt.13/10/2017 and has submitted the report to this office. These two buildings are located on Nanda Khaparkheda road. The Bal Mandir building is situated on Nanda side and Vidya Mandir building (G+2) is situated on Khaparkheda side. The Vidya Mandir Building is partly completed and being used as classrooms. Remaining part of the said building is in progress.

The above buildings are inspected by Sub Divisional Engineer, P.W.Subdivision Kamptee and following observations were made.

- 1) Bal Mandir building is completed in July 2016 and Vidya Mandir Building (G+2) is completed in June 2017.
- 2) Buildings were not completed under the supervision of the undersigned. Hence the undersigned can not accept the responsibility of structural design, reinforcement details inside the completed members of the structure. Hence this office is not responsible for design and quality control during construction.
- 3) However both the buildings are found in generally good and sound condition.
- 4) The details structural audit is already performed by the approved structural consultant by Shri.P.T.Mase & Associate, Nagpur and they have already issued the Stability Certificate.

In view of the above facts the following is being informed to you.

- i) The buildings are in good and sound condition. Hence both the buildings are safe to occupy and use for the intended purpose.
- ii) This observation is made subject to approval of fire safety scheme by the competent authority.
